TERMS & CONDITIONS

- **FOOD VENDOR INSURANCE:** ALL food vendors must provide valid Product Liability Insurance for the sale or distribution of any products (food, beverages, etc.) at the event. Food vendors must operate a quality facility staffed by clean, professional, and courteous personnel.
- **BOOTH SETUP & BREAKDOWN:** Vendors are responsible for providing their own tent, tables, chairs, and all required facilities. Booth space is provided with AC hookup where available. Setup and breakdown times will be communicated prior to the event. Vendors must be fully set up before the event opens to the public.
- **PAYMENT:** The \$300 booth fee must be paid in full to confirm and reserve your space. Payment can be made by check (payable to Bailey's Furniture), PayPal, or credit card. Spaces are not held without payment.
- **SPACE ASSIGNMENT:** Booth space assignments are made at Bailey's Furniture's discretion based on availability, vendor type, and event layout. Submitting this agreement does not guarantee a specific location. Bailey's Furniture reserves the right to limit the number of vendors in any product or service category.
- **CANCELLATION:** Cancellations made more than 14 days prior to the event will receive a full refund of the booth fee. Cancellations within 14 days of the event are non-refundable. If Bailey's Furniture cancels the event, all booth fees will be refunded in full.
- **CONDUCT & COMPLIANCE:** Vendors agree to conduct business in a professional manner at all times and to comply with all applicable local, state, and federal laws and regulations. Bailey's Furniture reserves the right to remove any vendor whose conduct is deemed inappropriate or disruptive, without refund.
- **LIABILITY:** Bailey's Furniture, its officers, employees, and volunteers are not responsible for theft, damage, or loss of vendor property before, during, or after the event. Vendors participate at their own risk and are solely responsible for securing their own merchandise, equipment, and inventory.
